Precise Biometrics signs license agreement with FocalTech Systems

Precise Biometrics has entered an agreement with FocalTech Systems Co Ltd for licensing of Precise Biometrics' product for fingerprint recognition, Precise BioMatch[™] Mobile.

The license agreement will generate royalty revenue based on sales of fingerprint sensors from FocalTech that includes Precise BioMatch Mobile. Royalty revenues are volume dependent and cannot be forecasted at this point. The agreement includes a limited initial fixed fee for the right to integrate and use Precise Biometrics' software and for support & maintenance, which will be recognized starting from the fourth quarter 2015.

"FocalTech is one of the leaders in multi-touch technology and touch panel controllers. The agreement with FocalTech strengthens our position as the leading independent supplier of fingerprint software for mobile devices", says Håkan Persson, CEO of Precise Biometrics.
